B) REGULATORY REFERENCES

This information notice aims to provide clarification regarding the protection characteristics, conditions of use, maintenance, washing and warnings and/or limitations of use of the Protective Visors PPE. The PPE can offer the necessary level of protection only if intact, correctly worn and fastened. In case of doubts or requests for clarification, contact your supervisor and, if necessary, the manufacturer and consult the instruction manual.

The Information Notice is supplied with each package and must be read carefully before use. This Information Notice is drafted according to UNI EN ISO 16321-1:2022 standard.

The PPE has been certified as Category II PPE for devices intended to be used to protect the person wearing them from the risk of being hit by slight impacts with foreign bodies; according to the essential health and safety requirements of European Regulation 2016/425. The R5 device complies with the requirements of UNI EN ISO 16321-1:2022 standard with the exception of the visual field, limited in the upper part. Frontal and lower vision is guaranteed.

C) IDENTIFICATION OF THE PROTECTION DEVICE MODEL

Protective visor R5 - Frame with 6 transparent polycarbonate screens.

D) INSTRUCTIONS FOR STORAGE, USE AND MAINTENANCE**• Wearing instructions**

Wear the PPE and position it correctly on the face with the screen covering the face in the right points and making sure it adheres well by adjusting the strap according to the user's face/head. The performance of the PPE is guaranteed when it is correctly worn and positioned. If any deterioration is visually appreciated, suspend its use and replace it with a new one. **Modifications to the PPE are not allowed.**

• Sizes

The device is available in One Size but through the use of the adjustable elastic it perfectly adapts to any face shape.

• Notes on packaging and storage instructions

The final packaging of the product must be done in such a way as to keep it unaltered until the moment of use and for the entire period of employment. The product in question has no expiry date; the product must be stored in intact and sealed packaging, as long as away from direct heat sources.

• Disposal

If the devices have not been contaminated with particular substances or products, they can be disposed of as normal plastic waste, otherwise they must be disposed of in accordance with current legislative requirements for special waste.

E) SPECIFIC INSTRUCTIONS FOR CLEANING AND/OR DISINFECTION

To clean the visor, wet a cloth with non-alcoholic soaps and disinfectants and gently wipe the visor and screen removing stains and dirt.

Any use other than indicated is to be considered improper and any damage is not attributable to the manufacturer.

G) WARNINGS

- Protective visors must be replaced whenever transparency is compromised by scratches or any opacity.
- Visors that have been subjected to impacts must not be used and must be discarded and replaced.
- Wear the PPE before being exposed to the risk against which the PPE is designed.
- Use only original spare parts supplied by the manufacturer.
- The PPE must be assembled in all its parts to ensure maximum protection.

K) PHOTOGRAPHIC ASSEMBLY INSTRUCTIONS

1. Rotate the frame so that the pins and guides are facing the user's face.
2. Pick up the visor and flex it slightly. Starting from the center, first insert the visor into the highest guide, then slide it into the lowest one. Once this is done, push the central hole into the central pin (horizontal) so that the PPE begins to take on a circular shape.
3. At this point, slide the visor into the outermost guides and then push the hole into the pin (horizontal) with your fingers.
4. Insert the visor into the last two guides and then push the hole into the pin (horizontal).
5. Use the film to cover the ventilation hole.
6. For added safety, attach the elastic loop by inserting it into the most comfortable hole.
7. The visor is ready.
